## COUPLE BOTH GUILTY OF ASSAULT

A man and woman who assaulted each other Monday night were both given suspended sentences with 12 months probation after pleading guilty at their first court appearance.

Katrina Condon, 23, and Louis Yourkin, 20, both pleaded guilty Tuesday to assault.

Yourkin also pleaded guilty to failing to comply with probation and possession of .58 grams of marijuana.

Court heard that the couple, who had been dating for about eight months, was at Condon's uncle's home for dinner on Monday when they began poking each other during an argument.

Yourkin slapped Condon and then she punched him several times in the face using her right fist.

Yourkin left the uncle's home and returned to the Albert St. apartment he shared with Condon to gather his things. When Condon arrived home there was another physical confrontation.

Both of them had clearly visible injuries to their face when they appeared in court Tuesday.

They must both provide DNA samples and are banned from owning any firearms for five years.

They are also not allowed to have any contact with each other.

Yourkin has also been banned from all non-medically prescribed drugs.

## May 14, 2011 - Notable Incidents

### Man arrested for resisting arrest

At 1240 am on May 14, 2011, a patrol officer checked a male in the area of Aylmer and King Street who was under the influence of alcohol. It was determined that the male was on conditions not to be drinking so the officer proceeded to arrest him. The male resisted the arrest struggling with the officer and pushing the officer away. The man was eventually handcuffed and escorted to the police station. Charged with resisting arrest and obstruct police is **Clayton Self**, 27 yrs of Queen Street in Lakefield. He was held to appear in court on May 14, 2011.

### Arrests made by the Peterborough Drug Unit, Active Crime, High Risk Offender Unit and the ERT Team

On May 13, 2011, members of the Peterborough Drug Unit arrested **Jessica Hoyle**, 23 yrs of Peterborough at a west end home in reference to an ongoing investigation. Hoyle is now facing the following charges, trafficking a firearm, break and enter and theft of a firearm, unauthorized possession of a firearm and knowledge of unauthorized possession of a firearm.

## Vehicle stop

On May 13, 2011, members of the Peterborough Drug Unit, Active Crime Unit and High Risk Offender Unit, conducted a vehicle stop with the assistance of the OPP in Trent Hills. As a result of the stop, **Ronald Martin**, 37 yrs of Peterborough was arrested. A total of \$1650.00 cash was recovered, as well as 373 grams of marihuana. Further investigation led to the recovery of a handgun in Peterborough. Martin is now facing the following charges, possession of marihuana for the purpose of trafficking, possession of a firearm while prohibited, unauthorized possession of a firearm, knowledge of unauthorized possession of a firearm, and possession of proceeds of crime.

On May 13, 2011, members of the Peterborough Drug Unit, High Risk Offender Unit and uniform patrol stopped a vehicle on McDonnel Street and Park Street. As a result of this vehicle stop and investigation, police recovered \$1950.00 cash, 3 grams of crack cocaine and drug paraphernalia. The following persons have subsequently been charged with the noted offences:

**Katrina Condon**, 24 yrs of Peterborough - Possession of cocaine for the purpose of trafficking, Possession of proceeds of crime and breach of probation.

**Louis Yourkin**, 20 yrs of Peterborough - Trafficking a firearm, Unauthorized possession of a firearm, Possession of a firearm while prohibited, breach of probation and breach of recognizance.

## Search warrant

On the night of May 13, 2011, members of the Peterborough Drug Unit, Emergency

Response Team, High Risk Offender Unit and Active Crime Unit, executed a search warrant at a Gilchrist Street address. As a result of the search warrant, 15.4 grams of cocaine were recovered, a small amount of marihuana (1 plant) and \$2390.00 cash. As a result of the search warrant the following persons have been charged with the noted offences:

**Matthew Fredenburg**, 25 yrs of Peterborough - Possession of cocaine for the purpose of trafficking, Possession of marihuana and Possession of proceeds of crime.

**Louis Yourkin**, 20 yrs of Peterborough - Possession of cocaine for the purpose of trafficking, Possession of proceeds of crime, breach of probation and breach of recognizance.

As a result of these investigations a total of 5 people were arrested, over 373 grams of marihuana was seized, as well as 18.4 grams of cocaine, \$5990.00 cash and a handgun.

Katrina Condon was released on a promise to appear, while the other four persons will appear in court on May 14, 2011.

The investigation is continuing at this point.

# Preliminary hearing begins in handgun case

How a Magnum handgun went from a secured lock box in the northwest-end house of a local doctor to the residence of an accused drug trafficker is the subject of a preliminary hearing that began Tuesday afternoon.

Louis Yourkin, 21, faces numerous charges including weapons trafficking and possession of drugs for the purpose of trafficking.

He was charged in May after police seized handguns following a vehicle stop on Water St. and a search of a Chemong Rd. home later that day.

The Crown's key witness, 24-year-old Jessica Hoyle, took the stand during Tuesday's preliminary hearing.

A publication ban prohibits reporting her testimony.

But Hoyle pleaded guilty Jan. 5 to the theft of three guns and the facts presented that day are not subject to a publication ban.

Hoyle was working as a cleaner at the home of the doctor, who had a personal gun collection of 28 firearms including five handguns, court heard.

During the search at the Chemong Rd. home in May, city police found a loaded Magnum, court heard.

The gun was traced to the doctor, who told officers he thought the gun was in its lock box.

Police asked him to take an inventory of his guns, Thompson said, and that's when he discovered two more missing.

The guns were all properly stored and locked, court heard, and the key to the room was stored in a different location in the house.

Investigators eventually turned to Hoyle, court heard.

Hoyle told officers she stole one gun in January, another in February and the third in April.

The guns were sold to Yourkin and another man named "Bubba" to pay off Hoyle's drug debt, court heard.

The allegations against Yourkin have yet to be proven in court. His preliminary hearing was scheduled to continue March 27.

Hoyle will return to court for sentencing April 16 while co-accused Katrina Condon, 25, and Matthew Fredenburg, 26, are scheduled to return April 10.
